BOARD MEETING MINUTES FOR MEETING OF NOVEMBER 10, 2016

The meeting came to order in the San Rafael City Council Chambers at 10:02 a.m.

MGSA Board Members Attending: President Dan Schwarz, Vice President Sean Condry, Regan Candelario, Andy Poster, and Adam Politzer were present. Jim Schutz and Dan Eilerman were absent.

Program Contractors Attending: Executive Officer Michael Frank, General Counsel David Byers, MarinMap - Wayne Bush, Taxicab Regulation Program - Jeff Rawles, and MCEP - Christine O'Rourke.

A. Minutes of September 8, 2016 Regular Meeting.

Motion by Condry, seconded by Poster to approve the minutes of the September 8, 2016 meeting. Motion carried 4-0 with one abstention by Candelario and 2 members absent.

B. Introduction of New MGSA Board Member Regan Candelario, City Manager of Novato

President Schwarz introduced Regan Candelario who gave a brief overview of his background. No action was taken.

C. Report from Executive Officer

Frank reported on Executive Officer activities since the last meeting. He mentioned the following: 1) The fiscal year 15/16 Audit is presently underway; 2) He is working with Board Member Dan Eilerman to get two data fields from the Assessor's Office for MarinMap; 3) Updates to the MGSA website because of the Grand Jury report and resubmittal of scoresheet to the Grand Jury; 4) Subpoena for all records related to one of our contractors; 5) A meeting and discussions with the company, Mobilite which approached MGSA regarding placing antennas and equipment on some of our streetlights; 6) The Executive Officer's focus on the professionalization of MGSA systems including the movement of files to a centralized cloud-based solution, procedure manuals, and participation in a survey and call on JPAs and whether there is a need for a centralized organization that focuses on JPAs.
