

BOARD MINUTES FOR MEETING OF MARCH 8, 2018

The meeting came to order in the offices of the Transportation Authority of Marin, 900 5th Street, San Rafael at 10:01 a.m.

A. Board Meeting Minutes of January 11, 2018

Motion by Condry seconded by Eilerman to approve the minutes of the January 11, 2018 meeting. Motion was approved 6 – 0, with Candelario absent.

B. Report from Executive Officer

The Executive Officer reported on work being done to wrap up the Animal Control contract in conjunction with the County as well as starting work on the upcoming MGSA Budget. The Executive Officer handed out a sheet titled, "All MGSA Programs Budget Planning" that he planned to send out to jurisdictions to assist them with budget planning (attached). The resolution was approved 6 – 0 with Candelario absent.

H. Annual Fiscal Year 2016-2017 Financial Statement and Auditor's Report (Frank)
